State of Emergency

- Declared again 5 Oct for one month initially
- The Czech Republic applied various immigration measures in relation to the COVID-19 disease outbreak.
- It was extended to 20 November.



General Immigration Measures

- All consular posts (embassies) of the Czech Republic are still open and working, but their operations are limited.
- The duration of immigration procedures remains the same.
- Generally, it is forbidden to travel freely from/to the Czech Republic, however there are many exemptions.
- Immigration Authority (MoI) limited its activities.



Entry to the CR

Immigration:

- All EU nationals and non-EU nationals are only allowed to travel with a specific purpose.
- It is forbidden to travel as a tourist or for a visit. See more at koronavirus.mzcr.cz/en

COVID-19 measures:

- The ability to travel is based on the nationality of the person (category of persons), and at the same time based on the country from which the person enters (where stayed longer than 12 hours in the last 14 days).
- Red countries Public Health Passenger Locator Form + RT PCR Test + Informing competent Hygiene Station.
- Orange countries RT PCR Test required for employees and students only.
- Green countries No requirements.



Contact Mol (Ministry of Interior)

- All former appointments stay valid.
- You cannot visit Immigration Authority without an appointment.
- You can arrange an appointment for the following tasks only:
 - Registration upon arrival including collection of biometric data,
 - Issuance of biometric residence cards,
 - Issuance of the bridging visa due to urgency (it must be proven),
 - Long-term residence permit following long-term visa,
 - Long-term residence permit for new born baby.

Other kind of application must be sent via mail or via data-box only.



Renewal of permit

- All residence permits and long-term visas can be renewed 120 days prior expiration at earliest and the last day of the validity at the latest.
- All renewal applications can be sent via registered mail or via data-box.
- It's very important to have your name on your post box and to inform authority about your current address of stay.
- Fiction of stay YES
- Fiction of employment (Employee card, Blue card) YES
- Duration of procedure (Brno): 3 months + 2 months (for biometrics).



Change of job with an Employee Card

A change of job notification can be sent via mail and it requires:

- Free vacancy (test of the labour market 10/30 days)
- Employment contract
- Proof that the former employment still persists or was terminated
- Diploma, qualification etc.
- Notification must be filed 30 days before the employment starts at the latest
- Notification must be filed within 60 days after the termination of the previous job at the latest
- Immigration Authority will issue a Confirmation on change of employer within 30 days. Only afterwards it's possible start working.
- Now, it's even possible in the first 6 months from getting the first Employee card.
- The above-mentioned is not required in case of exceptions (e.g. Czech diploma, new employer is supporting critical infrastructure).



Inviting family

- It's important to check the list of open embassies.
- Some embassies are accepting all kind of applications (e.g. Sydney, Soul, London, Brussels).
- Most of the embassies are providing limited services, in particular:
 - Work
 - Study
 - Family reunification (for spouses and minor children only)
- Their capacity is still not great. Embassies provide appointments in a several months time or based on a lottery (e.g. Ukraine).
- Sweetheart visa (from October 2020)
